NOTIFICATION

In exercise of powers conferred under clause (b) of section 22 A of the Legal Services Authorities Act, 1987, the State Government, hereby includes and declares the following services as Public Utility Services in the State of Tripura, for the purpose of exercising jurisdiction by the Permanent Lok Adalat at Agartala, in respect of one or more of those 'Public Utility Services' throughout the State of Tripura:-

- (a) Banking Service,
- (b) Services of Non-Banking Financial Institutions,
- (c) Service in Housing Sector,
- (d) Services of Private Educational Institutions.

2. This shall come into force with immediate effect.
