MEMORANDUM

Subject: Redressal of grievances relating to rights of the child under the RTE Act, 2009.

In continuation of this Department Notification NO.F.13 (3-60)-SE/GL-1/2011(V-11) dated, 29-11-2011 making declaration of local authorities for the purpose of implementation of different provisions of the RTE Act, 2009 and the State Rules as such within their respective jurisdiction, it is hereby notified that the local authority concerned shall also perform the function of grievance redressal under Section 32 (1) & (2) of the RTE Act, 2009

The notified Local Authority shall take into consideration the following factors while developing a procedure for filing and processing of grievances.

i) The local authority can accept written complaint made by any person on behalf of the child. Complaints could be sent by post, fax, or in person. A format for the purpose is enclosed.

ii) The notified local authority will develop a system of registration of grievances, and a receipt of registration of the grievance should be provided to the

complainant instantly.

iii) For the purpose of deciding a matter arising out of a grievance/complaint, the notified local authority may cause such verification and call for such information as it considers necessary.

iv) The grievance should be decided by the notified local authority within three months of its filling, after affording adequate opportunity to both parties. The decision of the notified authority under section 32(2) shall be a reasoned order, and should contain the details of the Appellate Authority (SCPCR/REPA) before whom an appeal can be preferred under section 32(3) of the RTE Act.

v) In respect of grievances relating to matters of urgency, such as denial of admission, etc, the notified local authority shall endeavor to decide the matter in a shorter time. Further, in respect of grievance relating to violation of Indian Penal Code, such as violence, child use, corporal punishment, etc, the notified local authority may facilitate filing of FIR before the police authorities.

vi) In respect of grievance registered before the notified local authority which requires to be decided by an authority other than the notified authority, such grievances be sent to that authority which is competent and empowered to decide the matter, and on receipt of such grievance, the other authority shall take steps to decide the matter expeditiously.

- Every notified local authority shall maintain a record of grievances filed vii) and decisions taken by it and submit a periodic report showing the number of complaints received, the number of complaints redressed etc. to the State
- The notified local authority shall keep aside fixed days/timings for hearing viii) grievances and for personal meetings with aggrieved parties.
- The Child Rights as in the RTE Act, 2009 shall be given wide publicity. The ix) lists of Child Rights (both in Bengali & English separately) are annexed.

ie list of the Rights of children as in the Right of Children to Free and Compulsory Education Act, 2009 and the Right of Children to Free and Compulsory Education Rules (Tripura) 2011.

- Every child of the age of six to fourteen years shall have a right to free and compulsory education in a neighborhood school till completion of elementary education.
- In case of admission up to class-V, the limit of neighborhood shall not exceed 01 K.M. and in case of admission from VI to VIII, the limit of neighborhood shall not exceed 03 K.Ms.
- The child failing to complete his/her elementary education shall be admitted in a class appropriate to his/her age.
- Every child shall have the right to get admitted in any school on the strength of transfer certificate.
- No child of the age of 6-14 shall be subjected to any screening procedure while admitting in the school.
- No capitation fee shall be required, to be paid to any school or persons by the child or his/her parents
 or guardian.
- Admission of at least 25% children (class-I and pre-school education) belonging to weaker section
 and disadvantaged group (as notified by the Govt) in a privately managed un-aided school from the
 neighborhood.
- No child of the age of 6-14 shall be held back in any class or expelled from school till completion of elementary education.
- Every child shall have the right to get elementary education without physical punishment or mental harassment.
- In case of need, students are entitled to additional instructions in class rooms by the Teachers.
- Every child of the age of 6-14 years reading in govt and govt aided schools shall get mid-day-meal on every working day.
- No child shall be denied admission for lack of age proof.
- In case of violation of any of the rights mentioned in the RTE Act, 2009, every child or his/ her parents or guardians shall have the right to lodge complaint to the Local Authority concerned seeking redressal.
- The complaint (s) shall be decided within 03 months by the Local Authorities.
- If not satisfied with the decision of any Local Authority, the complainant concerned shall have the right to prefer appeal to State Commission for Protection of Child Rights (SCPCR) or the Right to Education Protection Authority (REPA).
- Every child shall get one certificate from the head of the institution (Headmaster/ Headmistress) after completing his/ her education up to class-VIII.
