Sir,

The recruitment to non-gazetted positions is a very important factor for human resource development in Government of India and various State Government Departments. However, there are several challenges during recruitment process of non-gazetted positions. The main challenge is non-existence of proper examination centres where CBT can be conducted.

- 2. NRA proposes to set up exam centres all over the country on a PPP model. For this purpose, NRA would require suitable buildings space at important locations in the States/UTs. We would require around 10,000 sqft. of space at each such location.
- 3. I had requested earlier also on the above proposal along with appointment of a Nodal Officer. Some States/UTs have already informed us on the buildings/space available and also appointed nodal officers. However, this may need to be reconfirmed or updated.
- 4. I would, therefore, request you to instruct State Government Agencies/PSUs and Municipal Bodies to locate suitable premises for this purpose. NRA will take these premises on rental/lease basis for a period of about 5 years.

5. Further, it is requested that a Nodal Officer be appointed for this purpose who can coordinate with NRA. The Nodal point at NRA will be Shri Sanjeeb Kumar Mishra, Secretary-cum-CoE. The details of Shri Mishra are given below:
