NOTIFICATION

In public interest, the Government of Tripura is pleased to announce Motor Vehicle Tax concession in pursuance with notification of Ministry of Road Transport & Highways issued vide Notification G.S.R. 720(E) dated 05.10.2021 to provide concessions in Motor Vehicle Tax up to 25% in case of both non-transport and transport vehicles in the State of Tripura to the vehicle owners on purchase of new vehicles which are being registered against submission of 'Certificate of Deposit' under Voluntary Vehicle-Fleet Modernization Program (V-VMP) or Vehicle Scrapping Policy from a Registered Vehicle Scrapping Facilities.

However, no concession in motor vehicle tax shall be available for transport vehicles after eight (8) years, and for non-transport vehicles after fifteen (15) years, from the date of scrapping of the End-of-Life Vehicle (ELV) in a Registered Vehicle Scrapping Facility (RVSF), with effect from 1st April 2022, as per G.S.R. 720(E) dated 05.10.2021.
