**NOTIFICATION**

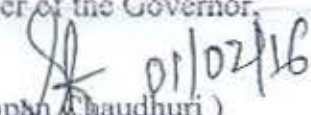

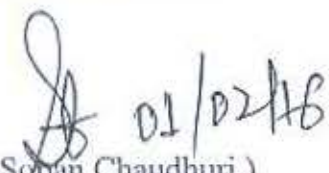
