# NOTICE INVITING REQUEST FOR QUOTATION (RFQ)

On behalf of the Hon'ble Chairperson, Teliamura Municipal Council, Khowai Tripura District (hereinafter called as TMC), the undersigned hereby invites Request for Quotation (RFQ) / Rate from the bonafide / eligible Vendors having experience in the relevant sector for Total Operation, Maintenance Work of existing LED Street Light Network through CCMS (Centralized Control Monitoring System) /(or) any suitable electronic centralised control system / any other technically fit system which includes replacing of damage lights/Spares etc. either by way of repair (in case of repairable) or by procuring new light/spare from their own resources (in cases of non-repairable lights), as may be required from time-to-time, on monthly basis, within Teliamura Municipal Council area for illumination of the entire streets of the TMC area within the existing coverage of total and not more than 3600 (Three Thousand Six Hundred) LED Street Light in poles spread in 15 MC wards for 1 (One) year. The Bid Closing date is on 28.05.2025 upto 03.00 PM and scheduled date of Bid Opening is 28.05.2025 at 04.00 PM.

General Terms & Conditions:

1. Eligible bidders shall participate in bidding by submission of Quotation/Rate (for monthly basis) for the above mentioned work in prescribed format Annexure-Q/1 only to be collected from Teliamura Municipal Council (TMC) Office (to be collected physically from TMC Office or may be downloaded from the annexure attached herewith alongwith all necessary required documents/instruments etc as may be sought for. Tender Box shall be closed on 28/05/2025 upto 03.00 PM (1500 hrs IST) after which no submission / request for acceptance shall be entertained. Quotation / Bidding shall not be accepted through e-mail/any electronic mode etc. Only dropping of physical Quotation in Sealed Envelop in the Tender Box kept at TMC Office (under CCTV surveillance) and quotation sent by post shall be entertained.

- 2. Quotations sent by Registered Post/ Speed Post or Hand delivered to the office of The CEO, Teliamura Municipal Council, Teliamura, Khowai District, Pin-799205, should reach on or before <u>28/05/2025</u> upto 1500 hrs IST. Quotations received after the due date and time shall not be considered under any circumstances.
- 3. The sealed cover envelop shall be superscripted by the expression QUOTATION FOR TOTAL OPERATION, MAINTENANCE WORK OF EXISTING LED STREET LIGHT NETWORK IN TELIAMURA MC AREA.
- 4. Necessary required documents/instruments to be submitted alongwith RFQ: a) Copy of Trade License b) Copy of GST Registration and up-to-date GST filing certificate c) Copy of PAN Card d) Working experience document of similar nature, if any e) Up-to-date IT clearance certificate f) In case of SHG/PACS/Co-operative Society Ltd., registration certificate g) Bank AC details h) Nationality Proof (Citizenship/PRTC/EPIC) of the intending bidder, not required in case of SHG/PACS/LAMPS/Co-operative Society Ltd etc. i) EMD @2% of the Monthly Cost (including 18% GST) offered by the bidder in response to the RFQ j) Bid Fee: @ Rs. 2000/- (Two Thousand) only k) any other document may be sought by Bid/RFQ issuing authority if necessary. In this respect signed Annexure-Q/2 to be submitted alongwith the Sealed Quotation.
- 5. **EMD:** Bidding / Sealed quotation should accompany EMD @2% of the Monthly Cost (including 18% GST) offered by the bidder in response to the RFQ. Rate of GST may differ as per guideline of GST authorities.
- 6. Performance Guarantee Deposit (PGD): Successful bidder (L/1) shall deposit Performance Guarantee of 5% (Five percent) of the Contract Amount as has been settled after being L/1 bidder. This guarantee shall be in the form of "Deposit at Call receipt or, Demand Draft or, Banker's Cheque or, Bank Guarantee" drawn in favour of the RFQ Authority Requesting for Quotation (ARFQ) [here, Chief Executive Officer, Teliamura Municipal Council] from a well-recognized scheduled/commercial Bank guaranteed by the Reserve Bank of India having branch at Teliamura, Tripura. In case the bidder fails to deposit the said performance guarantee within the period as may be prescribed, including the extended period if any, the Earnest Money (EMD) deposited by the bidder shall be forfeited automatically without any notice to the bidder. The earnest money deposited along with bid shall be returned after receiving the aforesaid performance guarantee by the L/1. The said Performance Guarantee / security money will be released after completion of tender period subject to full & complete satisfaction of the TMC without any interruption and as per T&C of this RFQ/subsequent Agreement/satisfaction

of the RFQ issuing authority, and also smooth functioning of the entire system. No interest will be paid to the bidders on PGD/security deposit.

- 7. **Bid Fee:** The bidders to pay Rs. 2000/- (Two Thousand) as Bid Fee to be paid through AC Payee Cheque in favour of the Chief Executive Officer, TMC or through online payment facility at TMC office by using Gpay/PhonePe etc any time after starting date of bid submission and before bid submission end date by the bidders. Bid Fee is Non-Refundable (*except in case of cancellation of tender before opening of bid, Bid Fee is Refundable*) and to be deposited to the TMC account automatically as revenue. Payment of Bid Fee is mandatory. Proof of payment of Bid Fee is to be submitted alongwith Tender Document Envelop which is to be dropped in the Tender Box. Tender of any bidder shall be rejected if found submitted without Bid Fee.
- 8. The works mentioned above should be carried out / taken up for execution within next 10 (Ten) days from the date of signing of Agreement, if so considered. Penalty @0.05% of the monthly settled cost / rate **per day** will be imposed upon the selected vendor (L/1) for any sort of delay beyond reasonable justification, which shall be solely determined by the RFQ Inviter i.e. the CEO, TMC, and except natural calamities and be adjusted with the final bill.
- 9. Period of tender is for 1(One) year which further may be extended as discretion/satisfaction of the tendering authority/TIA. It is also to be noted that if the existing structure of street lights needs to be changed or the Govt. decides to introduce new system like Solar panel or any other system etc., the tender period / work-order may be scrapped at any time giving 1 (one) months prior intimation to the Contractor/Vendor and payment will be made only for the particular period of work executed. No dissent / communication in this respect shall be entertained. Decision of the CEO TMC shall be final in this matter.
- 10. All the existing Street lights must be functioning during the tender period. The selected vendor shall take care of all the issues raised by local citizens and opinion of local Ward Councilor / Chairperson TMC shall have to be taken into consideration. The selected vendor shall fully responsible for successful Street Light operation, maintenance etc.
- 11. Switching On & Off of the Street Lights at evening and in the dawn time (shall depend upon season) should be done by the Contractor/Vendor through CCMS / any other centralized control system/any suitable & technically fit system. No compromise in this respect shall be entertained.
- 12. Cost for replacing of damaged lights either by repairing (repairable cases) or by putting new one (non-repairable cases) to be done by the selected Contractor/Vendor by purchase within the contract period. No separate bill in this respect or any respect shall be entertained / adjusted.
- 13. The undersigned reserve the right to accept or reject any tender / quotation, extend the validity for dropping/bidding period of Tender or cancel Tender at any time without assigning any reason thereof.
- 14. A separate Agreement with the 1<sup>st</sup> lowest bidder (L/1) will be signed after finalization of rate and issuance of work order. Within 10 (Ten) days of signing of the agreement, the L/1 bidder / selected vendor shall start functioning failing which penal action as per tender clause/agreement clause shall be taken.
- 15. Participating Tenderer/bidder should have previous experience of executing

similar nature of job with proven records to be submitted alongwith the tender / bid, failing which the bid may not be accepted at the discretion of the authority. On the other hand, any bidder may include and show such employees who are expert in this field with record/self declaration etc.

- 16. No condition of any bidder/selected vendor shall be entertained.
- 17. Any enhancement of rate within the validity period of contract (one Year) will not be considered unless there is imposition of additional levy/GST or increase of existing levy/GST by the Govt. otherwise such request will lead to cancellation of the work order without any cost to be considered by RFQ inviter.
- 18. Any addendum/ amendments/ corrigendum issued by the TIA/ARFQ shall be part of the bid Document. However, TMC shall bear no responsibility or liability arising out of non-receipt of the same in time or otherwise.
- 19. i) The Bid(s) will be opened on 28.05.2025 at 1600 hrs IST at TMC, which will be intimated. ii) In case of any un-scheduled holiday(s) or occurrence of some event beyond control of the bid inviting authority on the day of opening, the IRFQ will be opened on the next working day at the same time or time as may be settled later. iii) In case of any ambiguity, the decision taken by Bid Acceptance Authority shall be final. iv) Comparative statement of financial bid will be prepared and placed to the LPC/DPC for acceptance. v) Decision of the RFQ issuing authority shall be final.
- 20. RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS: TMC reserves the right to accept or reject any Bid or all Bids and to cancel the Bidding process, at any time prior to the award of Contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the reasons for such action.
- 21. Any issue / ambiguity etc shall be clarified by the CEO, TMC and that will be final & binding upon all.
- 22. ARBITRATION: The resultant contract will be interpreted under Indian Laws. Any legal disputes arising out of this are subject to jurisdiction of Khowai District only.
