I. Holding analogous posts on regular basis in the Parent Cadre/Department; OR

With 03 years service in the grade rendered after appointment thereto on regular basis in the Pay Band - 3 of Rs. 9,570 - 30,000/- with Grade Pay of Rs.3,500/- or equivalent in the parent cadre/department ; AND

Possessing Master's Degree in Chemistry or Bio-Chemistry or Dairy Chemistry or Food Technology or Microbiology or Food & Drugs from a recognized University established in India by Law or is an Associate of the Institution of Chemist (India) by examination in the section of Food Analysis conducted Institution of Chemist (India) or has an equivalent qualification recognized & notified by the Central Government for such purpose & has not less than 3 years experience in the Analyst of Food.

II. Has been declared qualified for appointment as a Food Analyst by a Board appointed and notified by the Central Government for such purpose. Provided that a person who is a Public Analyst on the date of commencement of the prevention of Food Adulteration (Amendment) Rules, 1955, or who has worked as a Public Analyst for a period of three years before such commencement may hold office as such subject to the terms and conditions of service applicable to him/ her even though he/ she does not fulfill the qualification laid down in clause thereof.

III. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years, as on the closing date of receipt of application. The conditions for deputation shall be governed/ regulated according to the normal terms and conditions for deputation issued by the Government of India from time to time.

IV. For the purpose of appointment on deputation basis, the service rendered on a regular basis by an Officer prior to 01-01-2006 (the date from which the revised pay structure has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/Pay Scale of the Pay Commission except where there has been merger of more that one pre-revised scale of pay into one grade with a common grade pay/pay scale, and where this benefit will extend only for the post(s) for which that grade pay/pay scale is the normal replacement grade without any up-gradation.


2. Application, in triplicate in the prescribed proforma, duly signed by the applicant, should be forwarded only through proper channel. The application, in respect of eligible candidates, who can be spared for taking up the assignment within one month from the date of intimation about selection, may be forwarded by the Cadre Controlling Authority duly verified/countersigned by the Head of Office or an Officer authorized to sign on his behalf, along with following documents:

- (i) Cadre clearance in respect of the applicant.
- (ii) Up-to-date Confidential Report Dossiers in original of the candidate or clear and legible photocopies of the ACRs of the last 05 years at least duly attested by an Officer not below the rank of Under Secretary or equivalent to the Government of India.
- (iii) Integrity certificate signed by an Officer not below the rank of Deputy Secretary to the Government of India.
- (iv) Vigilance Clearance Certificate indicating that no disciplinary or criminal proceedings is either pending or being contemplated against the Officer concerned and
- (v) Certificate indicating major/minor penalties imposed, if any, on the candidate during the last 10 years or a No Penalty Certificate.

3. The Curriculum Vitae (CV) duly supported by documents will be assessed by the Selection Committee while selecting candidates for appointment to the post on deputation basis.

(a) Officers who volunteer for the post will not be permitted to withdraw their names later on. Applications received after the closing date or without documents mentioned above or otherwise incomplete applications will not be considered.

(b) The application in triplicate should be forwarded through proper channel to the 'Commissioner of Food & Principal Secretary (Health), Tripura, Agartala' within 45 days from the date of publication of the advertisement.
